## DECLARATION OF SECOND INTERIM DIVIDEND FOR THE YEAR ENDED 31<sup>ST</sup> MARCH 2018

On 19<sup>th</sup> June 2018 the Directors of the Company declared a second interim dividend of 6.0cents per ordinary share amounting to \$6,226,166 out of the net earnings for the Financial Year ended 31<sup>st</sup> March 2018.
